
Privacy

Privacy Policy Hall Haul Website Privacy Statement

Types of Information We Collect

When you request information, register as a user, apply for employment or otherwise send us information, we may collect data such as your name, email address, mailing address, telephone number, and certain other information.

When you visit the Website, we may receive and record information from your computer and Internet connection, such as the IP address of your computer and/or Internet service provider, the date and time you access our Website, the Internet address of websites from which you link to our Website, the computer technology you are using, the pages you view, the links you click and your movements and preferences on our Website. We use technology, including "cookies" or small data files stored on your computer's hard drive, to collect information about your use of the Website. You can refuse cookies by turning them off in your browser.

To the extent permitted by applicable law, we reserve the right to combine the various types of data that we collect. In addition, from time to time, we may supplement nonpublic personal information you provide us with information from other sources. Thus, information we obtain through the Website may be intermingled with and used in conjunction with information obtained through sources other than the Website, including both offline and online sources.

How We Use Information

We may use your information for the purpose it was collected and for any of the following purposes:

To respond to a request that you sent us, such as a request for information;

To contact:
